- 5. Delegates Elevation Health presentation in regards to concussions and baseline testing. 30% of symptoms occur right away, the rest can be hours after an incident. Would a handout or presentation be better to offer coaches on how to screen or look for signs/symptoms. Question from the board was would Elevation be willing to set up a table during evaluation weekend to let parents know the service is available as many are unaware. Depending on how the receipt is written up, it can be covered by most insurances (Physio Assessment for example).
