

January 18th, 2023 Meeting Minutes

- 8. Old Business:
 - a. Small nets & bumpers have arrived at the North Arena.
 - b. Spring/Fall Ice needs to be decided on (camps, etc.) so we can book with the city in January by their deadline. CLMH will not be booking any spring ice aside from a couple Intro to Body Contact sessions which Connie will work to book with Rob. Possibly look into booking a fall pep camp.
 - c. Coach Selection Update Tabled due to Matt & Derrek not being present.
 - d. Coach/Staff Evaluation Form was sent to Rob and Tracy to review in Google Form format. This cannot be uploaded into the registration system as it is a link and not a downloadable form like previously used. To try this out this season, we will forward the link to managers to pass onto their parents and stress the importance of filling it out. If we get low responses, we will have to go back to a physical form in the registration to ensure we receive data back on our coaches, etc. Connie will forward it to directors to review, and if anyone has any questions or suggestions, send them to Connie, do not edit the form.
 - e. Development scheduling needs to be finalized for the remainder of the season. PEP will run until the end of February as Jason does not want to over skate the kids coming into playoffs, etc. Goalie development will be planned for every second week, referee development will be given another slot on Feb 14th. The last scheduled Coaches Hot Stove was disappointing. Only 3 coaches showed up to attend, are directors emailing the information out to their coaches (head and assistants)? When we ask what our coaches want from our association it is more development, yet they are not attending.
