 - a. AGM Director Intent deadline is April 13th. Only received 3 so far.
- 9. New Business:
 - a. Jersey Request received from the U18 Native Provincial Team. Were unable to purchase jerseys on time, hoping to borrow a set for the team. Lee motions for a set to be leant out to them, Matt seconds. All in favor.
 - b. Registration fees for 2025/26 discussed. Fee's have not been increased in quite a few years, meanwhile Insurance, ice costs and referee fees have increased each season slightly. Gord motions to increase fees 2% per division (to the dollar) for the 2025-26 season. Discussion held, Ryan seconds. All in favor.
 - c. Jaguars teams only have 1 per division each season, so a request came in to start coach selection for them earlier than the mainstream division. This will help them start planning their seasons earlier since they do not need to wait on evaluations. Gord motions that CLMH open the Jaguars coach application submission beginning of April, with a deadline of May 1st. Interviews will take place after that, with Coach selections being announced by the end of May. Brad seconds, All in favor.
 - d. Camrose Casino fundraiser is an option for CLMH and is looking for applicants. Can raise a good number of funds to help the association, but it does take some time to be selected and is not an easy application to fill out. Matt motions that CLMH start the application process and if/when selected can look for volunteers, could be done in place of a bingo bond. Ryan seconds, All in favor.
 - e. City Social Media Post was brought to our attention regarding the Allocation priority for facilities. CLMH is disappointed in the way the city and council went about this, as well as false statements being made. Committee will meet Monday to discuss questions our association has on this decision to be brought to council Tuesday.
